REGULAR MEETING MINUTES

Chairman Phiel called the regular meeting to order at 7:00 p.m. Present were all Supervisors: Phiel, Biggins, Ramsburg, Brauning and Sheppard. Also present were Solicitor Sam Wiser, Township Manager David Blocher, Police Chief Matt Trostel, Road Superintendent Chris Walter, Treasurer Camie Stouck-Phiel, and Township Secretary Michele Long.

Chairman Phiel led the Pledge of Allegiance.

Agenda Approval

Mr. Phiel stated we need to amend the agenda to add item 5i to the consent agenda, which will be 'approval of a waiver request for the bond of indemnity for a Special Event being held at The Barn Resort on July 26th' The event, 'Christmas in July' will consist of vendors selling merchandise to the public. This will not have any major impact and or damage to the Township roads, which would be what the required bond would be covering. Cumberland Township will be listed as additionally insured on their policy for this event.

Mr. Phiel asked for any comments or discussion from the hearing held prior to our regular meeting.

Mr made a motion to adopt ordinance 2025-202 to amend Parcel 09E12-0079A--000 located at 6 Kinsey Drive from Mixed Use (MX) to Residential (R). Second by Mr Motion Carried 5-0

Manager Report:

Mr. Blocher reported the following:

- Camie and I attended meetings with Straban Township, Abbottstown Borough, and East Berlin Borough to review and update a joint bid process as noted in the consent agenda. The Township will Bid with the municipalities as previously done for collection of municipal waste. Bids and information would then come back later this year for consideration by the Board.
- Camie has submitted the FHWA-536 report. This annual report is known as the Local Highway Finance Report. It collects data on how governments spend money on roads and bridges. The report details both revenues and expenditures related to local highway purposes, including funding sources and specific activities.
- Administrative Staff had a Clinical Review meeting with Benecon and Capital Blue Cross to review the Townships claims data. A copy of the Executive Clinical Review can be found in your packet for review.
- On behalf of the Township, I would like to extend my appreciation to staff, contractors, elected officials, and residents for a great Groundbreaking event held on June 19th.
- A Personnel expense report and projection analysis is almost complete we are breaking out one category deeper for better projection purposes.
- Highway Superintendent Walter and I will start working on an Infrastructure plan forecast for the next 10 years. This will include annual maintenance items, projected Maintenance items, and capital projects. This should help plan for the expenditures for Township Infrastructure such as roads and bridges in the future.
- On June 23, 2025, the Township administration held a meeting with SunLife to review Insurance coverage, offerings, and benefits.

- Wednesday June 25th staff and the Building Committee have been requested to review the Security Camera locations, Lock Controls, and Access systems for the Building Renovation
- Collective Bargaining begins June 24th, 2025, with the CBA committee.

Police Report:

Chief Trostel presented an oral and written report of police activities for the month of June including: 286 calls for service, 54 traffic stops, 13 criminal incidents and 5,016 patrol miles. Some highlights of the report were:

- Chief Trostle introduced intern Logan Brewer who started his internship with the Township on June 2nd, 2025.
- Chief Trostle announced National Night Out is on Tuesday, August 5th and will be held at 730 Chambersburg Road.
- Officer Hartley is still conducting spring range qualification and range training for the department.
- Officers Spidle and Rodriguez attended the 25th Annual Traffic Safety LE Seminar in York.
- Sgt. Rosenberger attended a response to the non-criminal barricade training hosted by the PA State Troopers Association.
- Officers had an additional instance of an elderly dementia resident who left her home on foot and could not be found by family and caretakers.
- Detective Higgs was recognized by the Adams County Domestic Violence Sexual Assault Task Force for his work in those areas.
- Speros Marinos of the Battlefield Military Museum dropped off some goodies for the officers along with a very nice note thanking our department for our efforts in de-escalation and mental health issues.

Maintenance Department Report:

Mr. Walter read the report for June and some highlights were:

- Mr. Walter stated the crew attended a Low-Volume Paving and Dirt and Gravel Road seminar hosted by PA Dirt and Gravel Road Center.
- They have been working on projects to prepare for surface treatments, including base repair on Blackhorse Tavern Road.
- Shoulder cutting on Red Rock, Blackhorse Tavern, Plank and Willoughby Run Roads have begun this week.
- The crew replaced and upgraded the storm water pipe and added a catch basin to the driveway entrance to the Administration building in preparation for paving during the remodeling project.
- Mr. Walter stated that with the rainy weather they have been catching up on vehicle maintenance in the shop.
- The second round of roadside mowing has begun and will continue, hopefully as drier weather moves in we will be able to make multiple passes to keep vegetation controlled.
- Tru-Green completed weed spraying around the signs, guiderails, rock swales and storm structures.
- We are assisting Franklin Township on a paving project in their area also as a multi-municipal project
